Invoices are due and payable under the following conditions:

Your account will be assigned a MAXIMUM CREDIT LIMIT, subject to review at anytime, and should your unpaid balance exceed this limit, you will be required to make a payment on your account prior to the due date or accept purchases on a "CASH ON DELIVERY" basis until such time as your balance is reduced to within your credit limit.

Invoices are due thirty (30) days following the date of the invoice, unless otherwise agreed to in writing by Superior Trailer Sales, Co.

Applicant agrees to pay an annual finance charge of 1.5% on any invoice remaining open after 45 days from date of invoice.

Applicant further agrees to pay expenses incidental to collection of any past due amounts including attorney's fees or collection charges and that proper venue for any enforcement of this agreement shall be in Dallas County, TX.

The conditions of this Credit Application shall be governed by, construed, and enforced in accordance with the laws of the State of Texas;

Superior Trailer Sales, Co. reserves the right to discontinue "CHARGE" shipments should your account become past due, if there is an ownership or name change, in the event of bankruptcy; or at any time Superior Trailer Sales, Co., for good cause, deems itself insecure.
